TZB opens westbound span to New Jersey

\$3.98 billion bridge comes in on time and on budget



The first span of the Governor Mario M. Cuomo Bridge was scheduled to open to westbound traffic on Aug. 25, after four years of construction that began in 2013. The eastbound span will open later this fall and the entire project is scheduled for completion next year, on time and

on budget. More than 6,300 people have contributed to the project – including our members – totaling more than 8 million hours of work. The \$3.98 billion, 3.1-mile long bridge is the largest in the history of the New York State Thruway Authority.

SRO members hear an upbeat state of the union report

A packed audience at the semiannual meeting heard the latest updates on the state of Local 825 from Business Manager Greg Lalevee and fellow officers.



Greg reported on the increasing strength of the funds. "Your funds are strong and in great financial condition, " he said. "This Local is strong. We are growing in numbers, influence and stature."

"We may face a number of challenges," he said. "But we are poised to meet those challenges head on as we look to the future with a commitment to maintain the greatness of this organization."

Long-time members honored

More than 400 Local 825 members were on hand to honor many of the long-term

members who were able to attend. Two of them, T. Allen Jones and Bernard Koerner Sr. were recognized for 70 years of service.

Jack Nacion, who barely retired a few months ago, has accepted the position of JATC Chairman. He replaces long-time chairman Jimmy Leo. Greg thanked Jimmy for his years of service and Jack for agreeing to continue as an active participant.

TTF projects in gear

Greg reported on the increase in DOT work and bidding of new projects, now that the Transportation Trust Fund is back in action. Paving projects have begun and are being followed by more road reconstruction projects.

Training milestones

The Training Center logged 798 students for 39,050 hours of training between January 1, 2017 and June 9, 2017. The winter classes had 104 students and they received 11,280 hours of training.

A call to veterans

Greg also appealed to members who are veterans to help establish an American Legion Post exclusive to Local 825, similar to one established by member veterans of Local 139 in Wisconsin.

'Transformational vision' sees Local 825 Technical College

When you look into the future, what do you see?

Some see increasing use of robots, driver-less cars and heavy equipment. Remote-controlled lawn mowers are already in use along the Garden State Parkway.

What will an operating engineer look like

ten years from now? We think they will need to be expert in GPS systems, which are showing up on every piece of new equipment: GPS survey, GPS bulldozers, sophisticated computers on cranes and the proliferation of drones.

These systems will be in constant need of troubleshooting and upgrade. Someone will have to know how they operate and how to develop software around them. Why shouldn't that "somebody" be us?

this means our members will receive credits at our facilities that will be accepted toward a degree.

We are planning to apply for accreditation as a stand-alone technical college and to have the ability to confer our own associate's degrees.


Becoming a technical college

ELEC promotes infrastructure, wins water victory

The ELEC labor management team has established itself as an effective advocate for our members and contractors.

Its 2016 Road to Repair campaign was recognized as a driving force behind passage of the new Transportation Trust Fund package and public question that secured gas tax revenues for capital transportation projects.

In 2017, ELEC shifted its focus to water and energy infrastructure. The Water Quality Accountability Act – which will generate water and sewer projects for our union contractors and members – was signed into law by Gov. Christie in July.

Sponsored by Sen. Christopher "Kip"

Bateman, the new law will improve the safety of New Jersey's drinking water by holding public water systems accountable for infrastructure improvements.

Sen. Bateman's bill will also require public water systems to establish a cyber-security program, formulate plans to make infrastructure improvements and schedule inspections, maintenance and repairs to keep our systems safe for future generations.

Thanks to the ongoing efforts of Mark Longo, Kate Gibbs, Daniel Ortega, ELEC has become recognized as a leading voice of infrastructure and labor issues in our area.



Market recovery pays dividends

ELEC's union contractors also continue to benefit from an expanding Market Recovery Program. Designed to help them win contracts in specific private-sector markets, the program has succeeded in increasing union market share and creating jobs.

As of July, approximately 75 contractors have successfully used the program. Approximately one-third of their jobs may be attributable to the grant program.

As of the same month, ELEC paid out about \$2.5 million in grants, securing more than 100,000 man-hours of work. This translates into \$7.8 million in wages and benefits for members. For every \$1 ELEC put out in grants, our members received more than \$3 back in wages and benefits.

Currently, we have \$4.5 million in grants awaiting bid results. These jobs would represent an additional 166,000 man-hours of work.

ELEC reimbursement program grows

ELEC continues to expand its credential reimbursement program. In the first six months of 2017 more than \$88,000 was returned to members, about 35% more than last year.

"The program has been a great success," said ELEC director Mark Longo. "Since the start of the program, ELEC has reimbursed members nearly \$500.000."

In 2017, ELEC added new credentials eligible for reimbursement. These were NCCO, New York and New Jersey crane licenses, OSHA ten-hour certifications for construction, general industry, maritime and disaster site workers.

Safe Crane effort adds to "win" column

In 2016, ELEC began a "Safe Crane" initiative. Working with the Training Center and Legal Counsel, we have developed a model ordinance for towns and cities. This ordinance will ensure that only responsible contractors and operators are able to receive permits to operate cranes within their municipalities.

In the first half of 2017, ELEC added 16 towns and one county to its "win" column for adopting a safe crane ordinance.
