Business Manager Greg Lalevee was on hand with state leaders to witness Gov. Phil Murphy sign the bipartisan public-private-partnership bill into law.

"We've been advocating for 'triple-p' legislation for the past several years," Greg said. "We're pleased to see Gov. Murphy make this a reality."

The new law will promote economic development through public-private-partnership agreements between government entities and the private sector for building and highway infrastructure.

The law also requires that building construction projects contain a project labor agreement.
