Another long-term initiative is training and development. From investing in our training centers, introducing programs like STEAM and Earn and Learn, we've continued our march toward becoming a technical college and eventually – possibly by mid to late next year – a full-fledged two-year college.

All of these initiatives serve the purpose of building a premier labor organization to represent our members well and secure their futures; to make sure our members are proud of this organization and to make people outside want to join us.

Our activities are being noticed. Organizing efforts are being met with success. The New Jersey Business and Industry Association has invited us to take part in their workforce training and development group, and having a seat at that table is a very good thing.

IUOE Local Union 825 Procedures for the Nomination and Election of Delegates to the General International Convention

I. Appointing an Election Committee

The IUOE Local Union 825 ("Local Union") Executive Board shall appoint an Election Committee consisting of five (5) members. The Election Committee shall, between all regularly scheduled meetings of the Executive Board, have decision-making authority for all election-related matters vested in said Board, including the authority to make, amend, or modify the election procedures. The Local Union appointed an Election Committee with James Buchany serving as the Chairman.

II. Combined Notice of Nominations and Election.

The Local Union shall give notice of the nominations and election by publishing a Combined Notice of Nominations and Election (the "Combined Notice") in the November issue of the Local 825 News which will be mailed to all members in good standing. To the extent feasible, the Combined Notice shall appear on the first page of said publication. If such is not feasible, a headline shall state, on the first page of the publication, the page in which the Combined Notice appears.

- Notice of Nominations. The nominations portion of the Combined Notice shall state that:
 - Members will choose Delegates to elect the General Officers of the International Union at the General Convention.
 - ii. That the number of delegates to which the Local Union is entitled is based upon the average number of members it has paid per capita tax through the month of September of the calendar year prior to date of the Convention.
 - iii. That, applying this formula, the Local Union is entitled to fifteen Convention Delegates.
 - iv. That in accordance with the Local Union Bylaws, six (6) of these Delegate positions will be held by those holding Local Union Office, i.e., by the (1) Business Manager, (2) President, (3) Vice President, (4) Recording-Corresponding Secretary, (5) Financial Secretary, and (6) Treasurer.
 - That the remaining nine District Delegates shall be elected by secret ballot.
 - vi. That each District can select one (1) Delegate to be sent to the Convention.
 - That the Local Union may send one Alternate Delegate to the Convention for each five regular Delegates to which it is entitled.

- viii. That, since the Local Union may send fifteen regular Delegates to the Convention, it may also, based upon the above formula, send three Alternate Delegates.
- ix. That to be nominated for District or Alternate Delegate, a member must be in good standing.
- x. That no member on dues check-off at the time of nominations, however, will be denied, by virtue of the non-payment of dues, the right to (a) be nominated, (b) vote in the election or (c) nominate or second any candidacy for Delegate or Alternate Delegate.
- xi. That nominations shall take place, at Regular District meetings, as follows:
 - District No. 1 (Nominations for two District No. 1 Delegates and at-large Alternate positions): On December 5, 2022 at 7:00 p.m. at Aloft Mount Laurel, 558 Fellowship Road, Mt. Laurel, New Jersey 08054;
 - District No. 2 (Nominations for three District No. 2 Delegates and for at-large Alternate positions): On December 7, 2022, at 7:00 p.m. at Sheraton Hotel, Raritan Center, 125 Raritan Center Parkway, Edison, New Jersey 08837;
 - District No. 3 (Nominations for two District No. 3 Delegates and for at-large Alternate positions): On December 12, 2022 at 7:00 p.m. at Holiday Inn, 100 International Drive, Mount Olive, New Jersey 07828;
 - District No. 4 (Nominations for two District No. 4 Delegate and for at-large Alternate positions): On December 14, 2022 at 7:00 p.m. at Operating Engineers New York Training Center, 96 Bates / Gates Road, New Hampton, New York 10958.
- xii. That the Election Committee Chairman will preside over the District Meeting nominations, which will be conducted from the floor.
- xiii. That a nomination must be seconded to be valid.
- xiv. That the nominating member, the seconding member and the nominee for either Delegate or Alternate must all be affiliated with the District from which the nominee is being selected.
- xv. That no member can make more than one nomination for each time recognized.

- xvi. That before being recognized, all nominating and seconding members must present acceptable proof of identity, such as a driver's license or membership card.
- xvii. That nominators must submit a written statement with the registration ("Book") number (which number the Local will provide to nominators and seconders at the time of nomination and seconding) for each nominated individual.
- xviii. That, at the conclusion of nominations, any candidate for District and Alternate Delegate nominated without opposition will be declared to have been elected by acclamation.
- xix. That, if any candidate for District and Alternate Delegate has opposition, an election by secret mail ballot will be conducted in January 2023.
- xx. That All candidates for election run at-large, meaning that although members of one District do not participate in nominating Delegates from another, members of all Districts may vote in the election that determines which nominees are ultimately chosen to represent each District.
- xii. That a background check will be conducted for each member elected by acclimation, and each candidate in the January 2023 election. The results of said background check will be a factor in determining eligibility for nomination or election to District or Alternate Delegate.
- b. Notice of Election. The election portion of the Combined Notice shall state:
 - That the Local Union is entitled to send six Officer, nine District and three Alternate Delegates to send to the Convention;
 - That, unless all District and Alternate Delegates to which the Local Union is entitled have been elected unopposed and by acclamation during the nomination process, an election will be conducted by secret mailed ballot;
 - iii. That the ballots will be mailed to the membership no later than a date given;
 - That, in order for a ballot to be counted, it must be received, no later than a date given, at the post office box designated for said purpose;
 - That a member must request a duplicate ballot no later than a date given;
 - That, in order to be eligible to vote, a member must be in good standing at the time of the election;
 - vii. That to be in good standing a member's dues must paid in full no later than November 30th. 2022.
 - viii. That members may be elected Delegate by a plurality (i.e., by receiving a greater number of votes than those received by their opponent) and need not win by a majority;
 - ix. That in the event of a tie, selection will be made by coin toss;
 - x. That the Local Union Bylaws prohibit candidates from acting as their own Observers, but that each candidate may have a member in good standing as of the time of the election act as Observer;
 - xi. That such Observers shall have the right to observe all aspects

- of the election, including the printing, preparation and mailing of the ballots, the transporting of the ballots from the post office to the place where the ballots with be counted and the counting and tabulation of the ballots:
- xii. That the ballots will be tabulated at a time, date and place given.

III. The Procedures for Mail Ballot Election.

- a. Post Office Boxes. The Local Union will rent two (2) post office boxes with a U.S. Postal facility located in Springfield, New Jersey or its vicinity. One post office box will serve as the repository for ballots cast. The other will serve as a repository for undeliverable ballots.
- b. Handling Undeliverable Ballots. A designated member of the Election Committee will open the post office box for undeliverable ballots each day during the balloting period. The undelivered ballots will be removed from the post office box and transported to the Local Union. The Local Union will make a good faith effort to obtain current addresses for those members whose ballots have been returned. Where alternate addresses are obtained, duplicate ballots will be mailed promptly.
- c. Control Number. A control number will be assigned to each eligible voter and indicated, alongside the voter's name, on the voter eligibility list. The number will be used solely to verify that blank ballots, or blank duplicate ballots, are sent to no one other than eligible voters.
- d. Ballot Package. The ballot package will be made up of, as further described below, the Ballot, the Ballot Return Envelope, and the Secret Ballot Envelope.
 - i. The Ballot. The ballot will contain each and every name of the candidates for District and Alternate Delegates. It will also contain voting instructions, that among other things, direct member that after voting they are to place their ballot into the secret ballot envelope, and, in turn, place the secret ballot envelope into the ballot return envelope for mailing.
 - ii. The Ballot Return Envelope. The Ballot Return Envelope will (a) be addressed to the post office box designated to serve as the repository for ballots cast; (b) contain a postage stamp or pre-paid postage permit; (c) contain appropriate space in the upper left hand corner of the envelope for the voter to indicate his or her name and address and to affix signature; and (d) bear, also on the upper left hand corner, the control number of the voter to whom the ballot package was sent.
 - iii. The Secret Ballot Envelope. The Secret Ballot Envelope will be free of any marking that could reveal the voter's identity. Its purpose is to facilitate a numerical control system (as recorded on the ballot return envelope) under which each eligible voter may cast a single ballot, while preventing the disclosure of which cast ballot corresponds to which control number and thus which voter.

e. Log Books

i. Undeliverable Mail Log. The Election Committee will maintain a log of all undeliverable mail. The log will set forth the

following information: (a) the date on which the post office box designated for undeliverable mail was opened; (b) the number of pieces of undeliverable mail retrieved from the post office box; (c) the names of the members for whom correct addresses were found; (d) the names of the members for whom correct addresses could not be found; and (e) the number of duplicate ballots mailed each day to members for whom updated addresses were found.

ii. Duplicate Ballot Log. The Election Committee will maintain a log of all duplicate ballots requested. The log will contain the (a) date of the request; (b) the name, and address of the member making the request; (c) the reason for the request, and (d) date the duplicate ballot was mailed to the member.

f. Retrieving & Transporting Ballots.

- i. Retrieving the Contents of First P.O. Box. On the date that the ballots are to be counted, the Election Committee and the designated observers will go to the U.S. Post Office to retrieve the ballots. The Election Committee, in the presence of Observers, will retrieve all ballots from the P.O. Box and ask the postal clerk on duty for all ballots that may not have been placed in the P.O. Box after it had reached capacity
- ii. Retrieving the Contents of Second P.O. Box. The Election Committee, in the presence of Observers, will open the second P.O. Box and retrieve any undeliverable ballots. The Election Committee will ask the postal clerk on duty for any other undeliverable ballots which may not have been placed in the P.O. Box after it reached capacity.
- iii. Written Certification. The Election Committee will request a written Post Office certification indicating the total number of ballots received during the election period.
- iv. Transporting Ballots. A designated member or members of the Election Committee will transport the ballots from the U.S. Post Office to the venue where they will be counted. The Election Committee will maintain custody and security of the ballots at all times. Observers may follow the Election Committee Members in their own vehicles. No Observer, however, may ride in the same vehicle as any member of the Election Committee. The tallying of ballots will commence immediately upon the ballots' arrival at the designated venue.

IV. Ballot Counting.

a. Removal and Counting Ballots. The Election Committee will remove and count the envelopes from the U.S. Postal Service mail sack, placing the envelopes in piles of one hundred (100). The Election Committee will announce to everyone present the total number of: (a) envelopes picked up from the post office; (b) envelopes returned as undeliverable on the day of the tally, if any; (c) envelopes returned as undeliverable throughout the entire election process; and (d) updated addresses the Local Union was able to find and confirmation that duplicate ballots were sent to those members. At the conclusion of the announcements, the Election Committee will set aside all undeliverable envelopes.

- b. Checking Voter Eligibility List. The Election Committee will cross check the name and control number on the ballot return envelope against the name and control number on the voter eligibility list, placing a check mark next to the appropriate member's name on the voter eligibility list. If a member's name does not appear on the voter eligibility list, or there is any discrepancy between the information on the ballot return envelope and the information on the voter eligibility list, the envelope in question will be designated a challenged ballot, and the envelope will be set aside. If two (2) envelopes are received from a particular member, the Election Committee shall only open the first envelope that was cross-checked. The Election Committee will place a note on the second envelope stating that the ballot is voided.
- c. Secret Ballots. Once the Election Committee verifies the eligibility of each member, the ballot return envelopes will be opened and the secret ballot envelopes will be removed. The ballot return envelopes will be set aside. Under no circumstances will a ballot be counted if the ballot or secret ballot envelope (as opposed to the Ballot Return Envelope) contains the control number or other indication of the identity of the voter who cast the ballot.
- d. Counting the Ballots. The ballots shall be counted once all secret ballot envelopes have been set to the side. Tabulation may be made in one of two ways:
- i. If by computer. Each ballot shall be scanned, and the scanner shall record the appropriate markings on each ballot. In the event that a member signs or otherwise indicates his or her identity on the ballot, or in the event that the intent of the voter cannot be determined, the ballot will be voided.
- ii. If manually. The members of the Election Committee shall divide into teams of two; one member shall call off the name of each candidate who received a vote, and the other member shall record the votes received by each candidate on the tally sheet.
- e. Certifying Results. After all of the ballots have been counted, the Chairman of the Election Committee will announce the results and sign the Certification.

V. Post-Election Process.

- a. Record Keeping. All ballots and all other records of the election shall be maintained by the Local Union for a minimum of one year, as required by Section 401 (e) of the LMRDA.
- b. Protests. Any member in good standing who wishes to protest the conduct of the nominations and election must follow the election complaint procedures contained in Article XIII, Section 13 of the Local Union Bylaws, and Article XVII of the International Constitution. In the event that the Local Union receives an election protest, the results of the election shall remain in effect unless and until the protest is upheld, and a decision made either by the Local, the International or the U.S. Department of Labor's Office of Labor-Management Standards (OLMS), to have the election rerun. The election results shall not be overturned unless an investigation into the election protest discloses violations that could have affected the outcome of the election.
