# Spring in sight as winter training ends

s temperatures begin to moderate, winter training classes wind down and the work picture continues at a strong pace. 2023 training hours were 33 percent higher than the year before and we have every reason to expect this interest in training to continue in the months ahead.

#### **Growing Stronger**

Our ranks are growing, thanks in part to the successes of our organizers and thanks to the 44 apprentices and 26 STEAM members who recently completed their years of training.

Apprentices who have completed their academic coursework in the Earn and Learn program will graduate from Hudson County Community College in May. They will have earned their associate degrees while working toward the completion of their apprenticeship. This a milestone for our Local and for Hudson County Community College. We continue to expand the academic portion of our apprentice program and are currently laying out a course schedule for all apprentices that will include Labor Studies, Construction Management and Surveying. We also are moving fourth-year apprentices toward NCCCO/Crane Classes, Drills and GPS classes before they graduate.

It's a tribute to our local that we continue growing stronger. We are moving closer to our

long-term goal of being the best source for operating engineers in New Jersey and five counties of New York State. And the desire to become a Local 825 operating engineer is as strong as ever, witnessed by 250 applications being snapped up in five minutes in October.

#### **State Representation**

We were proud to see our brother Latham Tiver take his oath of office and accept his seat in the New Jersey Senate after a hard-fought campaign. In addition to working to educate our elected officials on matters important to our livelihoods, it is gratifying to have our own voice in the New Jersey Statehouse.

# Semiannual meeting updates members on local's activities

early 500 members filled the East Brunswick Hilton's ballroom in January for an up to the minute update on all aspects of Local 825's activities over the past six months.

Business Manager Greg Lalevee reviewed the status of the Funds, which remain positive.

Greg recognized the funds staff for their dedication, hard work and genuine care they provide to each member and their families. Because many staff members are nearing retirement age, a thorough succession plan was put in place to ensure continuity in the event of retirements.

Administrator Chris Medich still leads the office and continues to mentor the department heads to identify potential leaders. Some departments were made more efficient and there is a high level of confidence that the Funds office staff members will continue to provide the level of care they have become known for.

## Apprentices and STEAM members

Forty-four apprentices graduated from the program last year. Which is twice as many as the previous year. Covid had extended the duration of many apprentices. Some had been in the program as many as 10 years, due to covid and other impacts during that time.

Greg gave a shout out to Willie Vaccaro, Shana Grace and the entire training center crew for their efforts throughout the period to graduate so many apprentices.

Also graduating were 26 members of the STEAM program. STEAM was developed in

2018 as a five-year training focused on the paving industry. The program began with 35 students and of those, the first 26 were recognized last night. Twenty-one students remain in the program, many of those having joined after the program first began.

## 250 Applications – gone in five minutes

In October, the latest batch of applications were made available through an online portal. In five minutes they were gone, showing the high demand to join Local 825. Forty new apprentices will start the New Jersey program and 10 will join the New York program in the Spring.

The meeting was followed by the usual social hour with light food and drinks. The next semiannual meeting is scheduled for June 17 in a new location: the Prudential Center, 25 Lafayette Street, Newark, NJ

## Winter weather arrives in time for winter classes

#### Temperatures hovered in the high 20's on the first day of training

The annual ritual of winter training coincided with a drop in temperatures in early January. The day began under clear blue skies and cold but that didn't stop the dedicated men and women who were there to kick off the

first training programs of 2024 at both the New Jersey and New York Training Centers.

Training Director Willie Vaccaro and this year's instructors met with members and apprentices in the shop to review the do's and don'ts. This year there will be a total of 10 instructors at both facilities. After a brief address, members split into training groups with some heading outdoors and others remaining in indoor classrooms.

New Jersey classes include 360 forklift;

Bauer/Casagrande; basic crane; basic combo; basic dozer; basic excavator; CDL prep; GPS dozer, excavator, rover; paving classes (including milling machine, paver, asphalt roller and transfer machine); utility class / trench class; and welding class.

New York classes include GPS dozer, excavator, rover; utility class / trench class; miller machine; paver; asphalt roller; and milling machine.

Classes are scheduled to end on March 15.



















# Be in control of your funds, update life events

curred over the past 12 months and report them to the Funds Office. Because if the your records are not updated, you may not like the outcome.

A marriage, the birth of a child, a divorce, it is up to

each member to make sure their records are up to date so that there are no surprises when it comes time to make use of those benefits.

In the case of a divorce, the Funds office likely needs to know some of the terms

of the divorce, along with having copies on file of any appropriate documents. The divorce terms absolutely have an impact on medical benefits and usually have an impact on retirement benefits. Make

sure everyone is accounted for and equally important, update your beneficiaries if they change.



# Successful organizing moves local closer to its goal

their record.

At the Semiannual meeting in January, Business Manager Greg Lalevee praised the work of Local 825 organizers and praised

The union's overall organizing strategy and goal is to be the only source of highly skilled operating engineers in our area. In 2023, Local 825 grew 233 members closer to that goal. This achievement is in line with its progress over several months. Since July 2023, the organizers have reviewed 170 surveys from operators seeking membership in Local 825. They have engaged in 233 relevant top-down initiatives, ranging from research to meetings, negotiations & bannering.

The Department also has held 138 interactions, including outreach to employees at nonunion companies. Additionally, it signed 10 new contractors to the Union's Construction Agreement:

 Digging & Rigging, a large non-union crane company based in Maryland and now only union in Local 825's jurisdiction; and



Kiely Construction. During the second half
of 2023, Local 825 concluded all issues
with Kiely and the Utility Workers Union.
After successfully defended ourselves from
the utility workers NLRB charges we then
welcomed 78 Kiely employees as members, greatly improving our market share of
utility work in Central and South Jersey.

Despite its successes, the organizers continue to fight for Local 825 and the rights of non-union workers. Hats off to them for their continued efforts.

# ELEC advocates for issues/projects important to Local 825

ELEC825, the Labor-Management team of Local 825, remains on top of issues and projects vital to the well-being of our members. The ELEC team helps to shape public policy for the construction industry in New Jersey and New York.

#### **In New Jersey**



ELEC has advocated for PSE&G's proposed Gas System Modern-

ization Program's third phase (GSMP III). While it has not been approved, it would strengthen the state's infrastructure and sustain thousands of jobs. Meanwhile, GSMP II was extended two years ago, so gas upgrades will continue under that program for two more years.

ELEC staffers are currently working with environmental and business groups in an effort to expand the state's water work opportunities. During the past year they succeeded in getting \$300 million added to water work from the state's budget.

ELEC also has filed a notice of appeal of the newly proposed rules for the state's environmental justice law, which far exceed anything discussed at stakeholder meetings.

#### **In New York**



Issues include the progress being made on Route 17 construction and participating in public meetings addressing the

entire project that are continuing. New York's

budget faces a \$4 billion deficit this year, so we will have to work hard to ensure transportation funding remains a priority.

Last year, NY voters passed the \$4.2 billion Environmental Bond Act, which targeted water infrastructure, such as drinking water projects, sewer projects and lead pipes. NY Gov. Hochul then added another \$500 Million to the fund. We intend to work with local governments and legislators to ensure the Hudson Valley gets its fair share of those projects.

We will also continue to work on New York's energy policy to steer it away from its over emphasis on banning natural gas and, instead, advocate for more reliability and affordability by keeping natural gas in the mix.

Children of our members are also eligible for scholarships from several Central Labor Councils and Building Trade Councils.

# Water main break: another wake up call

The need to upgrade our water infrastructure is beginning to soak in, with a flood on Rt. 22 in Watchung providing the most recent wake-up call.

Local 825 and ELEC 825 have been advocating for the need to update New Jersey's and New York's aging water infrastructure for the past few years. Unfortunately, it sometimes takes a water main break to focus attention on the problem.

In Cranford and Linden, NJ American Water announced plans for a \$7.9 million project that will continue to improve the aging water infrastructure in those communities. The improvement is part of a multimillion-dollar



initiative to accelerate the renewal of water infrastructure that has reached the end of its useful life in more than 100 communities across the state.

The latest phase of the 17-building Motion Picture and Television Studio Complex includes a parking garage, paving/reconstruction, sidewalks and water lines construction. Nordic Contracting is the subcontractor for Turner Construction. An open-shop job, Nordic is employing Local 825's members.
