# TTF: Déjà vu all over again

he 2016 Transportation Trust Fund agreement expired this year and has been replaced with a version that we opposed. That version, led mostly by the Democrats, called for a nearly 2-cent-a-gallon gas tax increase each year for five years. It also decreased the percentage of funds used for road and bridge construction and diverted them to NJ Transit.

We favored an alternative bill co-authored by Senator Latham Tiver and Senate Republican Leader Anthony M. Bucco. It would not have raised the gas tax. Nor would it have diverted funds to NJTransit. In fact, it would have called for an audit of NJTransit. Despite the Bucco-Tiver alternative, the Democrats passed their bill on a party-line vote and sent it for Gov. Phil Murphy's signature.

# Tiver goes to bat for TTF

t didn't take New Jersey's newest state senator long to speak out against a Transportation Trust Fund proposal to raise the gas tax and divert money from road repair to NJ Transit.


Sen. Latham Tiver, working together with Senate Republican Leader Anthony M. Bucco, introduced a counter proposal to the Democrat TTF bill announced in March. That bill would raise the gas tax each year for five years and reduce the percentage of money going to roads and bridges and turn it over to NJTransit.

The Bucco-Tiver proposal would not raise the gas tax, would initiate an audit of NJ Transit and would not allow electric vehicle drivers to escape paying into road repair.

"Is it fair that New Jersey drivers pay more at the pump ... while giving more money to NJ Transit and letting EV drivers get a free ride?" asked Tiver.

Tiver backed up his proposal citing a poll conducted in March by his campaign. It showed that while 62% of New Jersey voters oppose a gas tax increase, opposition grows to 72% when they learn that revenues will be used to fund NJTransit instead of road repairs.

Despite his efforts, the Democrats' original bill was passed and sent to Gov. Murphy to sign into law.

The largest infrastructure construction program in the nation – the \$16 Billion Gateway Tunnel Project, – serves as a backdrop for our latest ad, showcasing the unique skills of our members.

The project kicked off with a groundbreaking ceremony last year, will eventually bring us to the banks of the Hudson River, where we will participate in digging the new tunnel to the New York border, beneath the Hudson River.

The ad's headline: Transportation: Light at the End of the Tunnel refers to the long wait between the tunnel's first groundbreaking in 2009 and the recent groundbreaking, which actually got the project moving. The ad also cites Local 825's recent experience in digging a 2.5-mile bypass tunnel 700 feet beneath the Hudson River to repair a section of the 85-mile long Delaware Aqueduct Water Tunnel. That project was the largest repair job ever undertaken in the more than 175-year history of the New York City water supply system.

Will there be a fourth annual event next year? Many members have already requested it. Odds are pretty good from the looks of it! Thanks to all who came out and had fun.




















# Member Assistance Program logs milestones

# Toxic Sites Get Funding

- The U.S. Environmental Protection Agency announced \$33 million in funding for three Superfund cleanup sites in New Jersey:
- The Matlack, Inc. site in Woolwich;
- The Raritan Bay Slag site in Old Bridge and Sayreville; and
- The Roebling Steel Company site in Florence

The bulk of the funding — roughly \$30 million — is going to the Matlack site, which was used for decades to clean trucks and tankers carrying hazardous substances. The Raritan Bay Slag site will get roughly \$1 million to help clean lead waste slag in the mile-long waterfront of Raritan Bay. And about \$2 million will go to the old Roebling Steel Company site along the Delaware River, which was once home to heavy steel manufacturing.

# Local 825 members donate 'gift of life'

ore than 100 Local 825 members responded to the call for blood at the first two blood drives of 2024.

The blood drives were conducted at the NJ and NY Training Centers in Dayton by Vitalant, one of the nation's largest nonprofit blood and biotherapies healthcare organizations, providing hospitals and patients across the country with a safe blood supply.

According to Training Director Willie Vaccaro, 36 units of blood were collected in New Jersey, exceeding the organization's goal of 25 units; and 53 units were collected in New York.

The blood donated saves the lives of trauma victims, patients with blood disorders, cancer and many other life-threatening injuries and illnesses. Shortages occur throughout the year, especially in this area of the country.

If you missed this opportunity to donate blood, watch for future opportunities to donate through Local 825, or look for a blood drive in your local community.



# Members welcome return of health fairs

one of the 2020 victims of the covid-19 pandemic was the Local 825 health fairs.

Prior to that time, health fairs were a regular activity in each district, allowing members and their dependents to have various health screens, blood work and to learn more about their benefits.

Covid-19 restrictions changed all that and it has taken more than three years to resume the popular program.

"We are excited to be able to offer health fairs once again to each of our four districts as part of our Wellness Initiative," said Sherry Viso, Funds Office administrator.

There are some new features to the new health fairs. Local 825 has partnered with Ramp Health, who will perform blood pressure screenings and biometrics. In addition, some lab services will be offered, such as:

- A complete blood count (CBC), used to diagnose and monitor numerous diseases.
- A Comprehensive Metabolic Panel (CMP), which provides information on the body's fluid balance, levels of electrolytes and how well the kidneys and liver are working.
- Cholesterol Levels
- PSA tests for men
- And a Hemoglobin A1C test, which measures average blood sugar levels over the past 3 months.

Many of the Local's Health Partners will be in attendance as well as Fund's staff. Before

# Route 22 work stalls before completion

oute. 22 traffic still slows down as it passes Echo Lake Park in Mountainside. That's because the \$9 million federally funded project to replace the culvert under the Route 22 stalled out when an adjacent property owner declined to authorize access to his property.

Part of the box culvert that goes beneath the eastbound lanes of the bridge have been replaced. One section still remains to be finished under the westbound lane. The original bridge was opened to traffic nearly 100 years ago, in 1929.

According to Lead Engineer Anthony Paglia, the state halted work until an agreement can be worked out. The project was being done in stages in order to maintain all travel lanes throughout the project. The completion date was originally expected in the fall of 2024. It is not yet clear whether that date is still feasible.
