Don't Blame Utilities, Fix the Power Shortage

As New Jersey ratepayers reel from rising electricity bills, some voices in the political sphere are casting blame on PSE&G and JCP&L. It is a tempting narrative. Pick a villain, assign blame, and promise reform. But this oversimplifies a real, systemic problem: there is not enough power being generated to meet demand. Utilities may be easy targets, but they are not the root cause.

The Role of Electric Companies

Here is the simple truth: blaming utilities for rate hikes is like blaming your faucet when the reservoir runs dry. Utility companies do not, in most cases, generate the electricity that powers homes and businesses. Their job is transmission and distribution. They "pass through" power and ensure delivery, reliability, and safety.

Most generation comes from independent power producers and merchant generators, or from the regional grid. So when politicians or ratepayers demand accountability, pointing a finger at the "local wires company" ignores the real issue. There is not enough generation capacity in the system.

Infrastructure Is the Answer

Over the past decade, New Jersey has retired coal and older fossil fuel power plants. Those retirements are outpacing new buildouts, and it's created a supply gap just as demand surges from data centers and electrification.

Utilities must be allowed to do what they do best, which is maintaining and upgrading the delivery system. New Jersey must commit to expanding and modernizing the energy infrastructure needed to compete in today's economy.

Public frustration over high bills is justified. But misdirecting blame onto utilities is neither fair nor productive. It's time we shift from blame to action. Build more. Permit faster. Invest in dispatchable, clean generation. The path forward is serious infrastructure, not political theater.

Local 825 hosts NESC in Cape May

eneral President John Downey and Business Manager Greg Lalevee, President of the Northeastern States Conference (NESC), welcomed labor leaders for the 40th regional convention. The NESC strengthens brotherhood among IUOE locals by offering a forum to share updates and define common goals. Here are some highlights from the conference.

Training and equipment

The National Training Fund shared progress on new opportunities, including mobile and tower crane workshops, rigging and signaling programs, gas fusion training and expanded curriculum for dozer, loader, forklift, excavator and motor grader. The IUOE also entered a new three-year leasing program with John Deere, adding excavators and dozers to support hands-on instruction.

Pipeline and power generation projects

Pipeline Director Paul McCormick reported on major projects in the region. The Iroquois Gas expansion, with compressor stations in New York and Connecticut, is set to nearly double capacity by mid-2026. National Fuel is preparing new infrastructure to power large facilities, including the Micron chip plant in New York and gas-to-hydrogen conversions in central Pennsylvania. These investments underscore the essential role of reliable power generation in the future economy. "There is a significant amount of replaceable pipe here in the Northeast," McCormick noted. "The opportunities are substantial, and the work will create good jobs for our members."

Multi-local organizing campaigns

Local 825's campaign at J.F. Kiely Construction was recognized as a model of effective multi-local organizing. After years as a non-



union contractor, Kiely signed an agreement that brought in more than 100 members. This fall, a 9a shop agreement added 20 more, securing lasting gains for Local 825 and increasing momentum for surrounding locals.

Building on that success, locals across the Northeast have organized nearly 200 additional operators and maintenance personnel at ReWorld Energy facilities. Following a first contract at ReWorld Plymouth in 2023, Locals 158, 877, 4, and 542 joined forces to expand representation and position members for strong first agreements.

Building hope for 22 veterans

With Thanksgiving on the horizon, Operating Engineers Legion Post 532 continues its mission of service and support for veterans in need.

In partnership with the Foundation for Sustainable Veteran Housing and American Legion Post 3, Post 532 organized Rock the Foundation, a benefit concert in Atlantic City. Proceeds will help fund a new legion hall in Westfield, NJ, with expanded meeting space and 22 fully furnished apartments for homeless veterans on the upper floors.

"The project was inspired by Operation 22" explains Joey Bove, "which seeks to confront the high rate of veteran suicide, estimated at 22 per day nationwide. There are currently 442 homeless veterans in New Jersey. If every county built 22 units, we could help end this crisis."

In the months ahead, Operating Engineer veterans will donate their time and expertise to demolish the current Westfield post and prepare footings for the new building.
